**Date:** August 21 & 22, 2010

**Time:** 9a.m. - 5p.m. Saturday  
10a.m.- 4p.m. Sunday

**Location:** Oscoda Beach Park on East River Road off US Hwy 23. Downtown Oscoda on beautiful Lake Huron.

**Eligibility:** Only handcrafted items and artwork by amateur or professional artists/craftsmen is allowed. **No kit work or buy/sell items will be permitted. Three (3) photos of your craft are required with your application. Photos should show raw product, work in progress, and finished product. Also, a copy of invoices for raw materials used is required.** Your photos/invoices will be reviewed by the Art Committee who reserves the right of refusal at their discretion. Violators will be asked to leave the show without a refund.

**Responsibility:** All booth spaces are 12'x12'. Exhibitors must provide their own booth set-ups, tables, chairs, etc. Canopies must fit your designated area. No electricity is available. There is no professional security. You are responsible for your own booth(s). There will be **no refunds** on booth spaces. There will be a \$25.00 charge for all returned checks. No pets and no overnight camping at the Park or parking lots will be allowed in compliance with the Oscoda Township Ordinance # 113. If you wish to obtain the same booth space for the 2011 show you must pay/register no later than December 31, 2010.

**Sales Tax:** You **must** have a tax identification number or social security number. All exhibitors' names and addresses will be sent to the Michigan Department of Treasury at the close of the event.
