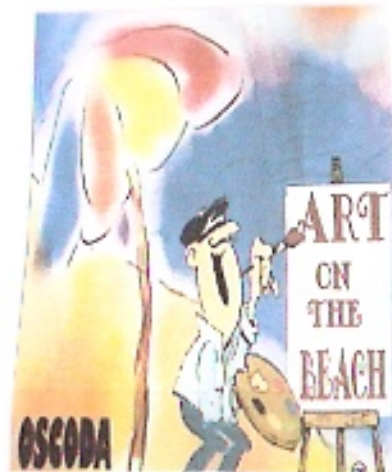

## Art on the Beach

**Date:** June 25<sup>th</sup> – 26<sup>th</sup>, 2022

**Time: Saturday: 9 a.m. to 5 p.m.**

**Sunday: 10 a.m. to 4 p.m.**

*It is the responsibility of all crafters/vendors to operate and function in accordance with any Covid-19 guidelines and protocols as directed by the Charter Township of Oscoda.*

**Locations:** Oscoda Beach Park, in Downtown Oscoda, at the end of River Road, overlooking beautiful Lake Huron.

**Eligibility:** “Art on the Beach” is open to both professional and amateur artists who have created original work: Original means a unique work created by the artist using his or her own skills and imagination, which they are entitled to copyright.

**Policy as to Reproductions:** Reproductions are allowed under the following circumstances: (1) when the original of the same work is also displayed in the booth; or (2) where other original(s) by the same artist are on display, together with reproductions of an unavailable original. No buy or sell items will be permitted. Three (3) photos of your craft are required with your application. Photos should show raw product, work in progress and finished product. Also, a copy of invoices for raw materials used is required. Your photos and invoices will be viewed by the Art Committee who reserves the right of refusal at their discretion. Violators will be asked to leave the show without a refund.

If you are a past crafter/vendor and have photos on file in the Chamber Office, new photos will

not be necessary. If your merchandise has changed since you were last at “Art on the Beach”, then new photos will be necessary.

**All booth spaces are 12’ x 12’.**

Exhibitors must provide their own booth set-ups, tables, chairs, etc. Canopies must fit your designated area. No electricity is available. There is no professional security. You are responsible for your own booth(s). There will be no refunds on booth spaces. There will be a \$25.00 charge for all returned checks. Pets must be leashed. No overnight camping at the beach or parking lots will be allowed in compliance with the Charter Township of Oscoda Ordinance #113. You will be assigned a booth space at Set-up/Registration, June 24<sup>th</sup>, 2022. Although we will try to get returning vendors close to, if not on their same space, we DO NOT guarantee any space to any vendor. We ask all exhibitors to donate an art or craft item to be auctioned on Saturday to benefit the event and a community non-profit organization (to be determined).

**Sales Tax:** State sales tax is the responsibility of the vendor.

**All booth fees will be \$85 per/booth regardless of registration date, except for:**

**Non-Profit Organizations (Members): \$0.00**

**Non-Profit Organizations (Non-Members): \$35**

*To receive confirmation, either please enclose a S.A.S.E. or include your email address.*

*Should you have to leave the park, you must close your booth(s) and not leave it for neighboring vendors to monitor.*
